Thank you for your interest in participating in the Tenth Annual Naglee Park Open Studios (NPOS) on **Sunday**, **June 2**, **2019**, **from 11:00 a.m. to 5:00 p.m**.

We are looking forward to our 11th year and hope you can join us.

This packet includes important information and forms that must be returned in order to participate as an artist in NPOS 2019.

The following forms must be **returned by April 15, 2019** to Marcia Trusswell, NPOS Artist Coordinator, 398 S 17th St, San Jose, CA 95112. If you have any questions, please email acnpos@nagleepark.org or you can leave a message on our voicemail at 408-384-8066.

- 1. Campus Community Association Release of Liability waiver. If you are under 18, your legal guardian must sign the form. If you are exhibiting your work at someone else's home, that person must also sign a release.
- 2. Artist Information Worksheet (attached). Information you provide will be used to market the event and to determine what we can do to help you be successful.
- 3. Check per participating artist, made out to CCA (write NPOS 2019 in memo line). \$50 per artist for artists residing outside Naglee Park, \$25 per artist for artists residing within Naglee Park.

Please keep in mind the following important information about the event:

- There is a limited number of slots available for artists. Return your package early to help ensure your spot.
- You must be present during the entire event.
- To participate, your studio or exhibit space (such as your house) must be within Naglee Park. If you don't live in Naglee Park, we have a limited number of spaces for non-Naglee Park artists.
- Alcohol may not be sold, but you can offer it free. (Be aware that you can be held responsible if anyone overindulges or if an underage person is served.)
- In addition to showing your studio on an event map, signage will be provided. Please use the signs we provide so that attendees can quickly identify participating studios.
- If you need studio/exhibit space, be sure to let us know on the enclosed Artist Questionnaire. We cannot guarantee studio/exhibit space.
- Please plan to attend a casual after-party on the evening of NPOS for artists and volunteers.
- This is not a juried event: we welcome artists of any level.



Once we have all your information, we will include your name on our website at www.nagleepark.org/npos.html. The final list of participants will be up by May 1: please check the website by that date to confirm that you are in the show. If your name isn't on the website, please contact the artist coordinator.

Please plan on attending the Artist Party on May 22 from 7-9:30 p.m. Artist materials for the day of the event will be available for pickup and it's a great place to meet up with other participating artists and volunteers. Most artists bring a smaller piece of work to the party so we can all see each other's work.
